

# REPORT ON INTERNATIONAL CHILD DEVELOPMENT PROGRAMME IN SOMALILAND



ICDP report in Somaliland – 2024

#### **Introduction:**

The ICDP program has been incorporating in CSSP project in Somaliland which has been implemented by Save the children since 2017 alongside the local partner of HAVOYOCO and the Ministry of Labor, Social Affairs and Family (MOLSAF). In 2024 project has trained and upgraded 4 project staffs based in Hargeisa, Somaliland as ICDP trainers, the trainers were previously trained as an ICDP facilitators by ICDP international team. The main purpose of the training was to establish the first ICDP trainers in Somaliland to create competent trainers who can train the local facilitators on ICDP program. The ICDP trainers were trained, guided and supervised by the Nicolette Armstrong throughout the process. In addition to that, the newly certified ICDP trainers created and trained community- based ICDP facilitators in Somaliland.

#### **ICDP** trainer's training:

Nicoletta is the chair of the International Child Development Program (ICDP) trained the team for fourth months (from August 2024 - November 2024) The training was largely online sessions, and Nicoletta and the team together developed comprehensive plan for completing the training. During the process Nicolette and the team had significant number of calls meeting by discussing progress and addressing challenges and way forward. The 4 ICDP trainers successfully completed the training, and they started to full the required assignment set by the ICDP for the certification of the Trainers.

#### **ICDP Facilitator's training:**



The certified ICDP trainers established and created four community-based groups of **16 persons** to train on ICDP program to be **ICDP facilitators** in Somaliland. three groups were based in the ongoing CSSP project targeted location in Hargeisa, Somaliland and the fourth group was selected from none-project targeted locations in Hargeisa. The purpose of training was to establish local facilitators who can implement ICDP sensitizations for caregivers/parents in their respective locations. The training was delivered full **5-days** of in-person training. The ICDP trainer developed their respective plans for supporting the facilitators and the plans were shared and discussed with Nicolette. During the training, the trainers used ICDP training materials which were provided by the Nicolette. After the completion of the sessions. Moreover the **15 questions** for facilitators where asked and discussed with the trained facilitators and they provided answers regarding the queries. During the process Nicolette and the team also had consecutive call meetings for sharing feedback and reflection and the way forward after all sessions were completed.

#### **Targeting audience and selection process:**

Training was targeted members from community champions of the area where CSSP project is implemented, and one group was identified from teacher in the city of Hargeisa. As per the discussion with ICDP team the participants were selected due to the following set of criteria:

- Can read and write Somali/English
- Willingness to participate the training
- Commitment to deliver the ICDP parenting into their localities
- Should be members who are involved in CSSP project
- Willingness to be a volunteers

#### Training approach and duration:

The training for ICDP facilitators was delivered in accordance with the ICDP procedures and approaches. The trainees were provided full 5 days of in face-to-face training where they have taken 4 hours per day started at 8:30 AM – 12:30 PM. The trainees were also introduced the key 8 dialogues of ICDP parenting program and as well as the facilitators' 7 sensitization principles. Moreover, the trainees were provided all relevant ICDP materials and documents for reference. The following materials were provided to the trainees:

- ICDP handbook 1 and 2(Somali version)
- ICDP pictures produced by SCI
- ICDP House banner
- Meeting Logbooks

#### Monitoring scheme and dairy:

Monitoring facilitators is key for ensuring the quality of conducting ICDP training in the community level. Therefore, to make sure the effectiveness of training the new facilitators the ICDP trainer have developed monitoring plan for facilitators. The monitoring was conducted through face-face meeting with the facilitators and call meeting through WhatsApp.

#### **Key observations noted during the training:**



- The facilitators fully committed and completed the training on timely manner as agreed with the facilitator and ICDP international team
- The Facilitators delivered and transferred the knowledge to caregivers/parents in their respective locations in Hargeisa.
- The facilitators successfully delivered the training as per the agreed ICDP rules and procedures set by the ICDP.
- Trainees were using people's examples and experience during the training
- The facilitators effectively collaborated with their supervisors (ICDP Trainers)
- The facilitators routinely filled their meeting Logbooks and shared with the supervisors
- The facilitators adhered and followed the key 7 sensitization principles of ICDP program
- The facilitators employed adult learning approaches during caregiver's sessions
- Homework and exercises were effectively managed.

#### **Conclusion:**

Finally, in Somaliland both ICDP trainers and facilitators have successfully completed their tasks by following rules and procedures set by the ICDP program. The training of the facilitators went well, and the facilitators have trained groups of mothers in their respective on ICDP parenting program. The team are sending their gratitude and appreciation to ICDP especially Miss. Nicolette Armstrong for her guidance and support that she has provided to the team during the journey. The team also hugely thank to Nicolette for allowing to give our certificates before the completion of the training due to her sincere assessment of the team as all the team have been working for almost 8 years in implementing Child Sensitive Social Protection project with key ICDP based parenting component in it.

#### **Recommendations and Way forward:**

- The facilitators should also be provided their certifications as they fulfilled their commitment
- The team have recommended to continually work with ICDP team for further future programming of SCI and HAVOYOCO as well.
- We strongly recommend for expanding the establishment of ICDP facilitators in Magalo Cad in Berbera and other location in Somaliland
- The ICDP trainers should also be upgraded into the next level when possible.
- The team suggested to establish **ICDP** in **Somaliland** as ICDP international members in Africa and the team has been eager to take the lead and make this happen in Somaliland.
